### **General Information:**

Clark County Fusion Volleyball Club is a non-profit, 501c3, organization established to develop a competitive program dedicated to advancing the personal and athletic aptitude of young athletes through the pursuit of excellence in volleyball while fostering a sense of community and promoting leadership. We are committed to providing a program of excellence to help middle and high school age athletes compete at the regional and national levels in Junior Volleyball. It's our mission to blend passion with perspective to combine love of the sport and intensity, with knowledge, integrity and discipline.

We provide an opportunity for highly motivated volleyball players to develop and enhance their skills through participation via a safe, enjoyable and nurturing competitive environment in which to train and flourish. Each program is designed to provide the best possible opportunity for young athletes to develop basic and advanced volleyball fundamentals, achieve success and accomplish their goals. We are committed to developing our athletes into positive, forward-thinking players who have the tools to excel in volleyball and in life, at any level. Our goal is to develop character through an environment that emphasizes earnestness, mutual respect and passion towards volleyball.

We believe competitiveness; hard work and fun can and should co-exist. We encourage our players to learn the game of volleyball, compete at their highest level and finish the season with a positive view of themselves and the game of volleyball. With dedication and commitment on everyone's part, we will have a successful and exhilarating season.

### **Introduction:**

As a player, and already accepted in Clark County Fusion Volleyball Club, we believe you should know what will be expected of you. This handbook has been prepared to describe the rules under which you will be expected to follow. If after reading these rules, you decide this is a Club you would like to play for, and be a part of, we welcome you to our Clark County Fusion.

The rules we have adopted for our Club are rules which have been proven by the test of time to improve volleyball skills, sportsmanship, integrity, competitiveness, etc. We zealously guard each player's right to succeed at their assigned age levels. Any player who does not abide by these rules is interfering with the standards of Clark County Fusion Volleyball Club, and risking the right to play for Clark County Fusion Volleyball Club.

### **CEVA and USA Volleyball:**

Clark County Fusion Volleyball Club is proud to be affiliated with Columbia Empire Volleyball Association (CEVA) and USA Volleyball. This gives our athletes the ability to compete at the highest levels with the quality of professional referee's and the backing of a national volleyball association. Each Athlete must be a member of CEVA prior to tryouts in order to participate and hold a full membership all Season.

### **Insurance:**

USA Volleyball provides insurance for each athlete. The plan provides secondary coverage if the family has other medical/dental insurance. If there is no other coverage, this will be the primary carrier. Insurance coverage begins once you have completed your CEVA membership online. The members are covered while participating in any Clark County Fusion events, including practice as well as tournaments, until the end of the season.

### **Parental Participation:**

Clark County Fusion Volleyball Club needs and encourages parental participation. Most parents find trips to tournaments very enjoyable. At some major events, parents are needed to help with chaperoning, transportation, laundry, etc. Please notify your athlete's coach or the Club Director if you are interested in becoming a team parent. All chaperones will have

to complete a USA background check and register with the USA Volleyball prior to participation with the team and players. Parents are welcome to “observe” practices to see what their athlete is learning. No parent is allowed on the court to help or participate per CEVA regulations.

**Team Parents:**

Each of our teams will need parent involvement. Our athletes and coaches spend sometimes an entire day at a tournament with little or no breaks. This means that our parents will need to organize a team parent/guardian that will facilitate and organize the food tables for their nourishment. We leave this up to each individual team’s families to organize and be involved. Questions should be addressed to the Club Director or Coaches.

**Player and Parent Behavior:**

Belonging to Clark County Fusion Volleyball Club is a privilege. This privilege can be revoked at the discretion of the Club Director. The Club should not, has not, and will not tolerate players or parents who behave in a manner which is disruptive or detrimental to the Club and its function.

**Parent Behavior:**

The Club recognizes and is understanding of parent emotions related to competitive sports. The major issues that arise relate to team placement of players, playing time and criticism of coaching decisions. Coaching decisions are not subject to parental interference. Parents may make inquiries for clarification with the coach at the appropriate time. Coaches are not obligated to take abuse. If a coach’s behavior is demeaning or detrimental to the welfare of a player, the parent may discuss the issue with the Club Director immediately.

Please remember that you are putting your child in a club to have them learn and grow in volleyball. Please do NOT coach your child from the stands, let the coaches do their job. Parents are NOT allowed on the court at any time, this includes the bench area during a tournament or practice. If your child needs something please give it to a coach or a director, do not go out on the court. The players should be prepared prior to the beginning of a match with water, and all items necessary to play.

Parents may NOT yell at an official, lines judge, or scorer, or discuss any calls made by an officiating referee, with that referee, at any time. These actions by parents can affect our team. CEVA can and will take action by either assessing a fee or taking points from a game. Parents will also abide by the food and drink policy and any other specific rules of each venue.

Our club is a proud member of CEVA’s Blue Ribbon Club. It is a voluntary, incentive-based program, that has been designed to begin to address a number of areas the CEVA staff have identified that will help continue to grow Junior Girls’ volleyball in the region in a positive and forward-thinking manner. The Blue Ribbon Club is designed to reinforce & incentivize club compliance with CEVA regional procedures, best practices, and guidelines, including, but not limited to, rules pertaining to conduct of coaches, parents and players.

By signing below Parents agree to the following:

- I/we will remain in the spectator area during all games.
- I/we will not advise coaches on how to coach, and will not make derogatory comments to coaches, officials, tournament directors or opponents.
- I/we will not approach coaches immediately before or during a match to discuss play or playtime and I will wait at least 24 hours after matches (before approaching coaches).
- I/we will encourage my daughter to communicate with her coaches regarding play time, skill level and concerns.
- I/we will maintain a positive attitude and emphasize the cooperative nature of our sport.

- I/we will support all attempts to remove belligerent, abusive or profane behavior around the team, coaches, and other families – verbal, physical, actual or threatened.
- I/we will honestly encourage and applaud the hard work, fair play and effort of ALL of our players and coaches.
- I/we will assume full responsibility for those persons whom we bring or invite along as spectators or participants to any practices, scrimmages or tournaments.
- As a Parent or Guardian of CCFusion player I/we agree to pay the amounts due, and to be fully bound by the terms and conditions of this Contract.
- I/we will encourage hard work and honest effort that leads to improved performance and participation.
- I will support and encourage attendance of ALL practices, competitions and tournaments.
- I/we understand and agree to the following policy on play time: CCFusion's focus is to provide specific technical training to all players. Playing time in matches and tournaments is not guaranteed. Play time is determined by the coach and may depend on the position of each player, skill level, and commitment at practices, behavior and attitude.
- I/we will not use alcohol, drugs or tobacco at practices, scrimmages or tournament sites.
- I/we will uphold and abide by the rules and guidelines set forth in the CEVA Junior Girls Handbook located on the CEVA Website – [www.cevaregion.org](http://www.cevaregion.org)
- I/we understand that any violation of this agreement may result in suspension and/or removal of me and/or my daughter from the team (and that all fees are still due and payable in full).
- I/we understand that the rules and policies and statements herein are not inclusive.

Parents that are not following these rules will be asked to leave the tournaments. Parents are asked to be courteous spectators. Threatening behavior or speech to anyone, within our Club, or third parties, will result in your athlete being asked to leave. Clark County Fusion Volleyball Club will NOT allow any behavior of this nature.

#### **Grievance Procedure:**

In a continual effort to assist the athletes in preparing for real world independence, athletes are expected to make decisions on their own. Therefore lines of communication between the administration, coaching staff, athletes, and the athlete's parents are as defined.

Players are to discuss any questions/comments they may have directly with the coaching staff, first. If they feel uncomfortable talking directly to their coaches they may discuss the matter with the Club Director. Parents are not to get involved until these steps have been taken. If the matter has not been resolved then a meeting with all parties will be scheduled.

A. Player discusses matter with the Team Coaches first.

B. If Player still does not resolve issue, they may request a meeting with the Club Director.

C. If further discussion is required, a meeting will be scheduled by the Club Director that will include the Club Director, Team Coaches, Player and Parents.

Should an issue or concern occur during a tournament, parents must wait a full 24 hour period from the end of the tournament before addressing the issue with the team coaches. At the end of those 24 hours, you may contact the team coaches to set up a meeting for all parties to discuss the issue or concern.

Any concern can be addressed with the Club Director either through email or via phone.

#### **Player Behavior:**

Each player, as a condition of Club membership, agrees to abide by the USA Volleyball Participation Code of Conduct which includes the USA Volleyball Disciplinary Policy. In addition, Clark County Fusion Volleyball Club has adopted, and each player must agree to the following:

- I will conduct myself in a manner to bring credit and prestige to the team.

- I will make every effort to attend and be on time for every practice, match and team function scheduled by the coach. I will inform the coach personally if I cannot make a scheduled event.
- I will communicate constructively both on and off the court for mutual understanding.
- I will willingly accept all coaching comments and assignments.
- I will not comment on the errors of my teammates, as I know no one is trying to make a mistake.
- I will participate with full effort/intensity, to the best of my ability, in all training and competition, and be an active participant in all group discussions to reach a true team consensus.
- Play time is determined by the coach and that play time during tournaments is not guaranteed. I understand that I will have every opportunity to prove myself at every practice.
- I understand and agree to the following policy on play time: CCFusion's focus is to provide specific technical training to all players. Playing time in matches and tournaments is not guaranteed. Play time is determined by the coach and may depend on the position of each player, skill level, and commitment at practices, behavior and attitude.
- I will uphold and abide by all the rules and guidelines set forth in the CEVA Junior Girls Handbook located on the CEVA Website ([www.cevaregion.org](http://www.cevaregion.org)) .

A player is not merely an individual; a player also represents both the team and the Club. A player's conduct reflects not only the coach's training, but the philosophy of the entire Club as well. A player's actions, because a player is a leader, must therefore be without reproach.

The use of alcohol and drugs by players is strictly prohibited. If you are caught or suspected of consuming alcohol or using drugs, consequences will apply. The club Director has the right to suspend or terminate the player's membership within the club..

Coaches, teammates, opponents and officials will be treated with the utmost respect. Players will not bully, be a part of bullying, annoying or acting out on any teammates, parents or coaches. Appropriate consequences determined by the coach and the Club will be executed.

#### **Player Scorekeepers/Referee/Line Judges:**

Players serving as down referees, scorekeepers or line judges will abide by the following:

1. Arrive on time to perform their duties.
2. Lines judges will stand alone while performing their duties and pay close attention to the match.
3. No talking during the match when performing officiating duties.
4. Not use cell phones or other devices, eat or engage in any other distracting activities during the match.
5. Pay attention. Every point is critical in every match. Officiating errors can significantly affect the outcome of a match. Officiate each match with all the attention you would want given to your team's match.

#### **Transportation:**

There is no transportation provided by Clark County Fusion Volleyball Club. Each parent is responsible for transporting their athlete to and from practice and tournaments. Coaches are not responsible to provide transportation at anytime for athletes. Parents are encouraged to set up their own car pools.

Practice dates, time, and locations are determined by school availability and coaches. Please pick up your child on time; our coaches' time is valuable and they would like to go home once practices have ended. If we have a problem or issue with your child being picked up, the Club Director will address each individual situation.

#### **Dress Code:**

All players should wear appropriate clothing for practices. It should not reflect other clubs, affiliations or teams. Your clothing should not offend parents, athletes, administrators, coaches, etc. In the event that a player reports for practice in clothing which administrators and/or coaches consider inappropriate, the player will be asked to change. Appropriate athletic shoes are required. In regards to tournament dress, all athletes will wear the appropriate uniform. The uniform needs to be complete with assigned jerseys, warm ups, knee pads, spandex, socks and shoes. We do recommend ankle supports but they are not required.

#### **Equipment:**

Players will be supplied with the equipment necessary to perform their assigned duties. It is solely the responsibility of the athlete, and injury will occur if she chooses not to wear knee pads or misuses the equipment. Each athlete is responsible for bringing a whistle to every tournament for officiating.

#### **Personal Property:**

The Club is not responsible for any personal property. If you wish to protect anything from loss or damage, carry it on you, or don't bring it. We do not accept responsibility for lost, stolen or damaged property. This includes cell phones or any other electronic device. While it is not a Club policy, many of our coaches enforce a "no cell phone use" rule during tournaments, practices, and team bonding events.

#### **Emergency Procedures:**

In the event of an emergency, the following procedure(s) will be followed:

1. 911 will be called
2. Someone will be sent to meet and direct the paramedics
3. The emergency card with the pertinent medical information will be pulled
4. The parents, guardian, or whomever is designated on the athletes forms will be notified as soon as possible
5. The attending staff will remain in charge until the Club Director or parents arrive

#### **Absence/Tardy:**

If a player is going to be absent/tardy to practice or a tournament, they are responsible for contacting the coach. Coaches will establish appropriate procedure to notify them. If it becomes habitual or disruptive, it will be discussed with the Coach, Director and parents. Unexcused absences/tardiness may result in a loss of playing time. If there needs to be a prolonged absence due to illness, family emergency, injury, etc. please notify the Coach and/or Club Director.

#### **Coaching Staff:**

Clark County Fusion Volleyball feels that coaching is the single most important element for your athlete's development in learning volleyball skills. We feel we have put together one of the finest and most complete coaching staffs in the Region. All of our staff have been background checked and have received Safesport, concussion, Impact, and Diversity and Inclusion training. We are looking forward to a great year and the opportunity to work with your athlete. Coaches for the upcoming season are listed on the website.

#### **Season Length:**

All teams will begin their season mid-November and ends in either April or May depending on team.

#### **Practice Schedule:**

All teams practice twice a week in two hour intervals. Practice times, dates and locations are determined by school and coaches availability. We try to keep your team on the same day, time and location. However, there are times that schools are busier than some and rescheduling may be necessary. We strive to be consistent but we do not have control

of the schools schedules. Some practices and tournaments will be held on Sundays. In addition to practices, our athletes will also receive access to A3 training.

### **Clark County Fusion Volleyball Club Diversity and Inclusion Statement:**

Since Clark County Fusion Volleyball Club was founded in 2014, we have been committed to creating a diverse community comprised of families from the greater Vancouver/Portland area. The Pacific Northwest is a diverse place, and we are committed to reflecting the vibrant mix of cultural, religious, economic, racial, ethnic, sexual orientations, and family structures that are part of our everyday lives. We have a zero tolerance approach to discrimination, victimization or harassment. We believe a diverse and inclusive volleyball community makes us better informed, more compassionate, and better prepared to affect positive change. Our families, club directors and coaches represent an increasingly broad spectrum of economic backgrounds, family structures, racial, ethnic, and gender identities. We believe this diversity of experience equips our athletes with the perspectives and skills necessary to thrive in a complex, multicultural, and increasingly connected world.

### **Transgender Equality Statement:**

We aim to provide a welcoming and supportive environment for people to be who they are, irrespective of their gender identity. We understand and respect that there can be differences between assigned sex and gender identity and expression and we value the unique contribution of all players, coaches and families, including individuals who identify outside of the gender binary. We will also seek to provide a supportive environment for people who are considering, undergoing or who have undergone transition while adhering to USA Volleyball guidelines.

### **Registration & Tuition:**

Club fees are due at the time of tryouts. Club fees can be paid in two options: Full payment at commitment (with applicable discounts), or on a scheduled payment plan with the Deposit amount due at the time of your commitment letter being signed to the Clark County Fusion team. Scheduled payments are not equal due to the fact that a majority of the Club's expenses are paid in the first two months of the Club season. Failure to contact Clark County Fusion prior to payment being late will result in penalties and/or player may not be able to participate in practices and tournaments.

Our Late Fee Schedule is as follows: Failure to make payment within 5 days of your due date will result in a late fee of \$50; Failure to make payment by the 1<sup>st</sup> of any subsequent month will result in an additional late fee of \$50. No single invoice shall have more than 90 days' worth of late fees, and will be capped at \$200. Failure to pay any account balance overdue by 90 days will result in the termination of your Payment Plan and the remaining outstanding team fees will become due immediately in full according to your Financial Contract. You will then be invoiced for the outstanding balance including any incurred late fees on all applicable invoices; The final Invoice is subject to the same terms as listed above. Any past due invoices of 90 days or greater are subject to Collections and will be pursued against the signer of the financial contract.

Airfare Costs, Hotel Room Fees, or any other expenses directly related to your player incurred by Fusion will be invoiced and payable by the due date on said invoice. If you are on a payment plan, these fees will be added to your normal monthly invoice as an additional line item.

We accept payments by check, cash or credit card. If paying by credit card, there will be a fee added to cover the cost of a credit card transaction. Any returned checks will have a \$50 fee added to their transaction for bank fees.

-All fees set forth in the Financial Contract are the responsibility of the named & signed Parent/Guardian

-No refunds will be given for money raised in the name of the Club through fundraisers or sponsorships.

-If a player does not attend a tournament, fees are not refunded.

-Actions will be taken legally against any responsible party that does not pay their membership in full as agreed.

#### **Termination of Enrollment:**

If it becomes necessary for a player to leave Clark County Fusion Volleyball Club, it is the responsibility of the parent/guardian to notify the Club Director in writing. The player's and guardian's commitment to a team is an agreement to pay for the season in full. In the event that a player withdraws before all fees have been paid, all Club fees are still due and payable regardless of the reason. If a player chooses to leave the Club during the season for any reason, the entire season fees remain the responsibility parents/guardians. Clark County Fusion Volleyball Club does not release player's or their guardian's from their contractual obligations to the club. Clark County Fusion Volleyball Club reserves the right to refuse service.

#### **SPECTATOR CODE OF CONDUCT**

##### **I WILL**

1. I WILL abide by the official rules of USA Volleyball.
2. I WILL display good sportsmanship at all times.
3. I WILL educate myself on the unique rules of this facility and abide by them.
4. I WILL generate goodwill by being polite and respectful to those around me at this event.
5. I WILL immediately notify the Event Director and/or Program Administrator in the event that I witness any illegal activity.
6. I WILL acknowledge that the spectator seating around the courts are for the primary use of those watching the match in progress.
7. I WILL acknowledge that spectators may rightfully choose to remain in a seat for an entire match without switching sides of the court when the teams switch.

##### **I WILL NOT**

1. I WILL NOT harass or intimidate the officials including line judges and scorekeepers.
2. I WILL NOT participate in any game or game-like activities unless I have a current membership card with USA Volleyball.
3. I WILL NOT bring and/or carry any firearms at any USA Volleyball event.
4. I WILL NOT bring, purchase, or consume alcohol at any Youth/Junior volleyball event. WARNING! Risk of injury from flying objects incidental to the sport of Volleyball may occur at this event. Attend at your own risk. Please pay close attention to your surroundings and be on alert at all times, especially during active play.

#### **USA VOLLEYBALL JUNIOR CLUB PERSONNEL CODE OF ETHICS**

**It is the duty and obligation of USA Volleyball affiliated Junior Club Program administrators, directors, coaches and other club personnel to assure the following Code of Ethics is followed and adhered to by all individuals who have an active role in a USA Volleyball Junior Club Program in any Region of USA Volleyball.**

**In a continuing effort to promote safe, healthy and ethical communication, relationships and treatment of all USA Volleyball players and personnel, all adults associated with a junior club program must read, accept and submit this Code of Ethics before they are eligible to actively participate in a junior club program associated, affiliated, or participating in USA Volleyball.**



1. All adult club personnel affiliated with a junior program must be a registered member with a Region of USA Volleyball and USA Volleyball.
2. All adult club personnel including coaches, chaperones, assistant coaches, trainers, etc. affiliated with a junior program intending to participate in USA Volleyball must have an approved and current background screen on file as per USA Volleyball policy. It is intended that the term 'all adult club personnel' be all inclusive and not limited to only those categories identified herein.
3. A head coach or assistant coach affiliated with a junior program must also: be an adult (see Region definition of an adult) and be IMPACT certified according to USA Volleyball and Region policies.
4. If allowed by Region rules, an assistant coach who has not yet met the age of majority in the state of residence must be supervised by a head coach recognized by the Region and must meet all applicable Region and USA Volleyball requirements. Individuals who are registered as junior players and also have an interest in coaching should contact their region regarding coaching eligibility.
5. Responsibilities:
  - A. A head coach or other equally qualified club personnel must be present at all practices and competitions. A head coach, adult club representative personnel or registered chaperone must be present during team-supervised travel. This individual shall be responsible for the moral, legal and ethical well-being for each participant during team/club activities.
  - B. Coaches shall understand the unique power of a coach-athlete relationship. Coaches and all other club personnel shall not exploit athletes and shall avoid any relationships which could compromise the integrity of the learning and participation process, impair their professional judgment and/or take advantage of a situation for their own personal gain or gratification.
  - C. All club personnel must understand that all forms of sexual abuse, assault or harassment of a current or former athlete are unethical and illegal even when an athlete invites or consents to such behavior or involvement. Club personnel shall not engage in sexual/romantic relationships with current athletes or other participants over whom there is/was authority. See B above.
  - D. All club personnel shall insure that all individuals have met all Regional Volleyball Association and USA Volleyball membership requirements prior to participation in any club, team and/or Region/National USA Volleyball activity.
  - E. All club personnel must inform the players and their parent(s)/guardian(s) about any Region and/or USA Volleyball transfer policy. This policy may restrict or prohibit a participant from transferring to another club or team if specified criteria have been met. Likewise, all club personnel must inform the players and their parent(s)/guardian(s) of any rules or policies regarding coaching transfers during a particular season.
  - F. All club personnel shall abide by and inform the players and their parent(s)/guardian(s) of applicable regional recruiting policies.
  - G. All club personnel may not participate in, require another individual to participate in, or condone any act considered to be illegal under federal, state or local laws and/or ordinances.
  - H. All club personnel shall strive to educate their athletes and personnel to respect, honor and adhere to the rules of the facility being used during practices, tournaments or events. In this regard, the rules of the facility shall have priority over the rules of the Regional Volleyball Association.
  - I. All club personnel shall ensure that all activities are suitable for the age, experience and ability of their athletes.
  - J. All club personnel shall seek professional medical advice when making decisions regarding an injured athlete's ability to continue training or playing.
  - K. All club personnel shall, while serving in a professional capacity, avoid any drug, tobacco or alcohol use while in the presence of athletes.
  - L. All club personnel shall not supply or condone the use of drugs, alcohol, tobacco, fireworks, ammunition, firearms, knives or any item or material that can be used as a weapon, to any of the participants or athletes and shall report any

athlete using or in the possession of the same.

M. All club personnel shall not allow, encourage, condone or require any behavior that threatens an athlete's amateur status or Regional, USA Volleyball, school and/or collegiate eligibility.

N. All club personnel shall maintain all relationships with other club personnel on a professional and confidential basis.

O. All club personnel must be positive role models. This includes being courteous, respectful and polite to players, parents, other coaches, club directors, event personnel, and officials.

P. All club personnel will not engage in any physical, verbal or emotional harassment, abusive words or actions, or coercion of current and/or former athletes.

Q. All club personnel will immediately report any suspected case of illegal activity, abuse, assault, harassment, or ethical violations of this club personnel code of ethics to the appropriate authorities, including Regional Volleyball Administrators.

Any violation of this Code may result in sanction being issued against the club representative, the individual(s) and the club/team involved. These sanctions may extend to the loss of eligibility of the club representative, the individual(s), the entire club and the team involved.

I acknowledge that I have read, understand and agree to abide by the statements in this Code of Ethics.

**Photo and Personal Info Waiver:**

Team experiences enjoyed by our players during this year's volleyball season will be photographed and/or filmed and displayed on the Clark County Fusion website, flyers and other media sources (not restricted to outside press). In order to post players' pictures and information, including but not restricted to team and personal stats, we need permission from a parent/guardian.

I/we certify that I/we have received, read, understand and agree to be bound by the terms and conditions of this and the above listed contracts and agreements. In the event that there are multiple parents/guardians responsible for player and paying of Club fees, all involved must sign this contract and will be bound by all rules, agreements and policies outlined in this and every document listed above. (If more than 2 parent(s)/guardian(s) are financially and/or legally responsible for player, please request a second signature page.)
